This notification is made under the provisions of Section-11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013(Central Act No.30/2013), as amended by the Right to Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Telangana Amendment) Act, 2016 (Act No. 21 of 2017) to all whom it may concern.

A plan of the land may be inspected in the office of the District Collector, Medchal – Malkajgiri / Special Deputy Collector Land Acquisition (Inds), Hyderabad at Medchal – Malkajgiri District Collectorate Complex, ORR Junction, Keesara on any working day during the working hours. The Government of Telangana/Collector-cum-Appropriate Government is pleased to authorize Officer Special Deputy Collector Land Acquisition (Inds), Hyd at Medchal – Malkajgiri District and his staff to enter upon and survey land, take levels of any land, dig or bore into the sub-soil & do all other acts required for the proper execution of their work as provided and specified in section-12 of the said Act.

Under section 11(4) of the Act, no person shall make any transaction or cause any transaction of land i.e sale/purchase, etc., or create any encumbrances on such land from the date of publication of such notification without prior approval of the Collector.

Objections to the acquisition, if any, and claim from all the persons interested / affected for settlement by negotiation of the compensation, may be filed by the person interested in the land within 60 (Sixty days) from the date of publication of this notification as provided under section 15 of the Act before District Collector/ Authorized Officer
