Mines of coal, iron-stone, slate or other minerals lying under the said land or any particular portion of the said land, except such parts of the mines and minerals which may be required to be dug or removed or used during the construction phase of the project for the purpose of which the land is being acquired, are not needed.

A plan of the land may be inspected in the office of the Special Deputy Collector Land Acquisition (Inds), Hyderabad, 2nd Floor Medchal – Malkajgiri District Collectorate Complex, near ORR Junction, Keesara on any working day during the working hours.

SUMMARY OF REHABILITATION AND RESETTLEMENT:

In the process of R&R Survey, no PAF is partly affected, fully affected. No residence/House/ open Plot is affected under alignment and there is no displacement of families. Hence not entitled for any benefits under Schedule II of RFCTLAR&R Act.

Further, there are no Government buildings and other public common amenities, common infrastructure facilities are affected in the area under acquisition.

There are no such religious structures like Temple, Mosques, tombs, graves in the acquired land.
